Be sure to either include YEAR as well as BEDS\_CD in your joins, or restrict the set of rows from the Miscellaneous\_\* tables by using only the YEAR=2004 rows of the Miscellaneous tables.

Please note that if you are reading this with Microsoft Word, you can click on the page numbers in the contents list below to relocate to the beginning of that table description.

These tables are shipped with no indexes to economize on file space and download time. You will probably want to create indexes on BEDS\_CD and other key fields to improve your local query performance.

To ensure student confidentiality, the Department does *not* publish data for groups with fewer than five students or data that would allow readers to easily determine the performance of a group with fewer than five students. In the *Overview*, the pound character (#) appears when fewer than five students in a group were tested. In the *Analysis*, when fewer than five students in a group (e.g., Hispanic) were tested, percentages of tested students scoring at various levels are suppressed for that group and the next smallest group.
